WORK RESTRICTION

The contractor shall start construction no later than May 1st, 2024.

Within the limits of the moveable barrier, the Contractor shall not be allowed to perform any work activities that is not protected by the moveable barrier.

No traffic control devices or lane closures will be allowed between August 9th, 2024 through August 23rd, 2024 and during winter shutdown from November 1st, 2024 through April 1st, 2025.

COMPLETION DATE PLUS WORKING DAYS (D1)

Effective: September 30, 1985 Revised: January 1, 2007

Revise Article 108.05 (b) of the Standard Specifications as follows:

"When a completion date plus working days is specified, the Contractor shall complete all contract items and safely open all roadways to traffic by 11:59 PM on, **August 31, 2025** except as specified herein.

The Contractor will be allowed to complete all clean-up work and punch list items within <u>10</u> working days after the completion date for opening the roadway to traffic. Under extenuating circumstances the Engineer may direct that certain items of work, not affecting the safe opening of the roadway to traffic, may be completed within the working days allowed for clean up work and punch list items. Temporary lane closures for this work may be allowed at the discretion of the Engineer.

(*The completion date for <u>Stage 1</u> shall be <u>November 1, 2024</u>.)"

Article 108.09 or the Special Provision for "Failure to Complete the Work on Time", if included in this contract, shall apply to both the completion date and the number of working days.

CONTRACTOR COOPERATION

It is anticipated that this contract will be constructed concurrently with other roadway projects within or at the project's improvement limits. These projects may under contract concurrent with this project as follows:

IDOT Contract No. 60T46: FAI Route 90/94 (Kennedy Expressway) REVLAC RehabilitationContract 60T46 has an anticipated start date of April 1, 2023 with work taking place in 2023 and 2024.

Between April 1, 2023 and October 31, 2024, the maintenance of traffic under Contract 62K73 will be coordinated with Contract 60T46 as follows.

60T46 – Responsible for traffic control to close reversible lanes starting April 1, 2023 through the
duration of both contracts 60T46 and 62K73. Traffic control must remain in place until both
Contracts 60T46 and 62K73 have been completed and directed by the Engineer. Traffic control
must be removed within 48 hours of the completion of both projects.
