

- 2. BEFORE STARTING ANY EXCAVATION. THE CONTRACTOR MUST CALL "C.U.A.N." (CHICAGO UTILITY ALERT NETWORK) AT (312) 744-7000 FOR FIELD LOCATIONS OF BURIED ELECTRIC, TELEPHONE, AND GAS FACILITIES. NOTICE 48 HOURS IN ADVANCE IS REQUIRED.
- IDOT ELECTRICAL FACILITIES INCLUDING ROADWAY LIGHTING. FIBER OPTIC, ITS EQUIPMENT, TRAFFIC SIGNAL, AND PUMP STATION FACILITIES ARE LOCATED BY THE DEPARTMENT'S ELECTRICAL MAINTENANCE CONTRACTOR. CONTACT MEADE ELECTRIC COMPANY AT 773-287-7672. NOTICE 48 HOURS IN ADVANCE IS
