IDOT PROJECT LABOR AGREEMENT DETERMINATION

Re: FAI 80 – Interstate 80 (I-80), I-57 to Kedzie Ave, Contract Number 62N96, Cook County

{Letting: November 17, 2023, Completion Date: October 31, 2024, plus 5 working days}

In accordance with the Project Labor Agreement Act (30 ILCS 571), it is recommended that a project labor agreement (PLA) be utilized for the above-captioned Project. This recommendation is based on the considerations indicated below.

- 1) The Project is being awarded and administered by IDOT (i.e., not by another governmental agency).
- 2) The Project is being constructed using state or local funds only (i.e., no federal funds).
- 3) The overall size, scope, sequencing, logistics or other aspects of the Project make it particularly challenging to manage, and use of a PLA is expected to help assure that the construction work is performed properly and efficiently under the circumstances. See attachment A below.
- 4) The duration of construction activity on the Project is expected to exceed one construction season (i.e., 110 or more working days), or the nature of the Project results in a heightened need for labor force continuity and stability over a substantial period of time.
- 5) There is a firm construction completion date established for the Project thereby increasing the adverse consequences of any work stoppage or other labor disruption.
- 6) The time required to complete the Project is expected to extend beyond the expiration date of one or more existing collective bargaining agreements covering trades likely to be involved in the Project, thereby increasing the likelihood of work stoppage(s) or other labor disruption(s) during construction of the Project.
- 7) In the absence of a PLA, there is an increased likelihood of jurisdictional disputes among unions or of conflict between unionized and non-unionized workers on the Project that could have a potentially material adverse effect on the time, cost, or quality of work performed on the Project.

Upon your approval, the Department shall undertake to negotiate in good faith a PLA with the relevant labor organization(s), and shall include in all necessary bid specifications and other documents information regarding the actual or form of PLA that is to binding upon all contractors and their employees.

The use of Project Labor Agreement (PLA) for Contract 62N96 is consistent with all State and Local statutory and regulatory requirements.

Item 3: This project includes both State and Federal funding and the programmed cost for this project is estimated at \$6,200,000.00. The work to be performed under this Contract consist of the bridge rehabilitation, pavement overlay, guardrail replacements, placement of pavement markings, and all incidental and collateral work necessary to complete the project as shown in the plans and described herein. Roadway pavement rehabilitation is typically limited to HMA overlay on the bridge approach slabs and concrete approach pavement. The mainline pavement will not be resurfaced between the Cicero Avenue and 175th Street bridge as well as between the 175th Street and Kedzie Avenue bridge approaches.


This project is located on I-80 over Cicero Avenue, 175th Street and Kedzie Avenue in Country Club Hills and Hazel Crest, Cook County. Improvements on I-80 begin approximately ½ mile east of I-57 and end approximately ¾ mile west of I-294.

Item 5: The completion date is October 31, 2024, plus 5 working days for punch list and clean-up items.
